

Instructions for Faculty

Two Performance Periods

Performance periods vary for Clinical and Teaching/Research faculty. Clinical Faculty are evaluated in the spring of each year for the previous *Calendar Year*.

Teaching/Research and Administrative Faculty are evaluated in the summer/fall of each year for their performance in the last *Fiscal Year* (July-June).

When completing your forms, follow the reporting time periods as closely as possible to help avoid repetition of activities. Activities taking place over consecutive time periods may be included for each reporting period, but if possible, note the span of dates for the activity.

FARES Support

Use the CONTACT US link at the top, right of each screen if you need help.

- All support requests will be routed to your department administration as they are your primary support providers. Office of Faculty Affairs and Technical Staff will be contacted by the department administration for issues that cannot be resolved by them.

Browser Compatibility

The system is optimized for use with Mozilla Firefox 3.x. The latest version of Firefox can be downloaded for free from <http://www.mozilla.com/en-US/>. While the system can be used with Internet Explorer (IE) 6.x and later, there may be minor page formatting issues due to rendering differences between different browsers.

Getting Started

1. FARES is located at the following url: <https://fares.som.vcu.edu/>.
2. Before you can access the system, you will need to log in to VCU's single sign-on system using your VCU eID and password. [see screen capture below]
3. Enter your VCU eID and password and click **Login** to access FARES.

[Contact your department administrator if you do not know your VCU eID. Call the VCU HelpDesk at 828-2227 if you have forgotten your eID password. You will need your VCUCard number to request a password reset.]

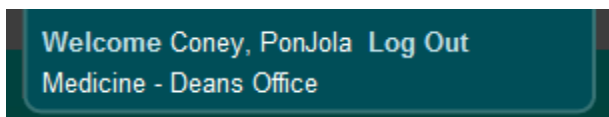

FARES Home Screen

Successful login through CAS will take you to the FARES Home screen. Your name, department and a link to logout of FARES will display in the top right corner of the screen.



A yellow Message Bar will appear at the top of the screen. Special notifications (such as scheduled system maintenance) and alerts (such as new, unresolved issues) will display in this message bar.

System Update Alert: FARES will be down for system update between 9 PM and 10 PM on Saturday, January 23.

The reporting period date will also appear in the upper right area of the screen.

For Clinical Evaluation Cycle,

January 1, 2017 – December 31, 2017

For Teaching/Research and Admin/Professional Evaluation Cycle,

July 1, 2017 – June 30, 2018

The FARES Home screen provides links to the screens for the forms you will complete for the reporting period. As a first step, you must complete the Activity Report and Performance Plan. Once you complete and submit these forms, they will be routed to your Evaluator who will complete your Performance Evaluation and review/approve your Performance Plan. If applicable, the Evaluator will submit your Activity Report, Performance Evaluation and Plan to the Reviewer for approval. Once approved, you will receive an e-mail notification that your performance evaluation is ready for your review, at which point you will be able to access the Approved Performance Evaluation and Plan using the link provided in Step 2.

Link to the Activity Report and Performance Plan, current Status (see system workflow tables below) and due date appear in the section titled “Step 1. Complete Activity Report and Performance Plan for <reporting period>.” Links to individual screens are provided in the first column, followed by the date the form was last updated. **Due dates are established by your department administration.**

[Note: Contact your department administrator if, for any reason, you will not be available to complete your Faculty Activity Report, Self-Evaluation or Performance Plan by the posted due date.]

System Workflow

If you are evaluated by the department chair, your evaluation will only have *one level of review*. If you are evaluated by the division chair, or another individual, your evaluation will have *two levels of review*. The following tables describe the system workflow for *No Action*, *In Progress* and *Submitted* status based on levels of review.

STEP 1 – Complete Activity Report and Performance Plan

From the FARES Home page, click on the link to ACTIVITY REPORT AND PERFORMANCE PLAN in Step 1 to go to the first screen for that report – Appointment Information.

Review and complete the information in each of the sections on this screen. After you complete each section, click the SAVE button to save the information you entered. A message will display (example shown below), verifying that your changes have been saved.

1. Faculty information

Prolonged leaves of absence of one month or more may affect your ability to meet performance goals for the reporting period. Use this space to describe leave of absence you feel need to be considered by your evaluator.

3. Significant role changes

Significant role changes may have increased or reduced your performance goals during the reporting period. Use this space to describe any significant role changes you feel need to be considered by your evaluator. [Example: Accepted additional duties as Vice Chair for Research beginning 6/15/09.]

Navigating in FARES

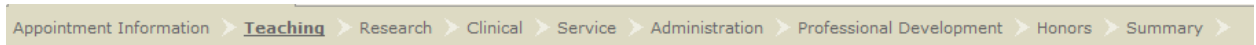
You can navigate between screens by:

- Clicking on the tab for the next section at the top of the screen. Switching sections by clicking on these tabs will **NOT** automatically save the form.

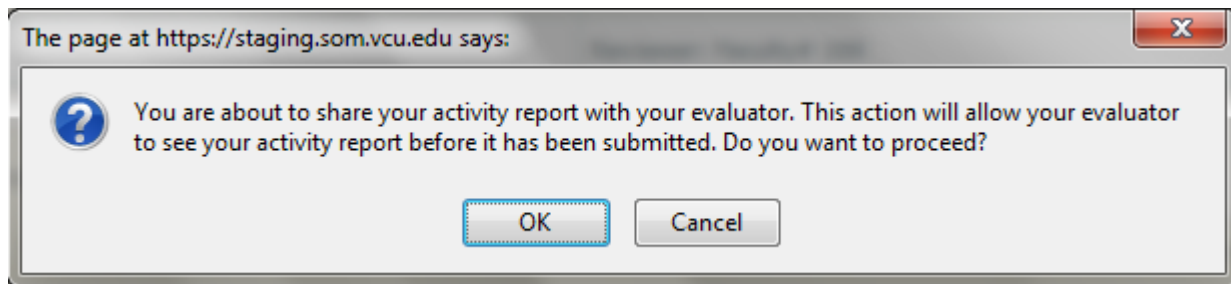


Sharing your report

By default, only you have access to your Activity Report until you click on **Submit** on the Summary tab, at which point the Evaluator will be granted view-only access to it. If you would like to **SHARE** your Activity Report with the Evaluator before submitting it for review, click on **Share My Activity Report** link located on the right and above the Activity Report tab.

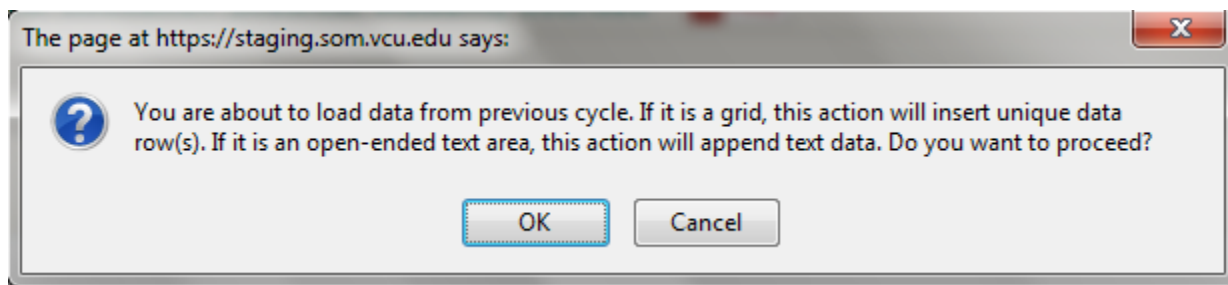

1. Undergraduate Medical Education (medical student) courses

The course information listed in this table was pre-populated from the SOM e-curriculum database. Use the following course/clerkship key when searching for courses:

MEDI-1xx – M1 Courses and Electives

MEDI-2xx – M2 Courses and Electives

MEDI-3xx – M3 Clerkships

MEDI-xxxx – M4 Electives

Enter the **Formal Teaching Contact Hours, Other Contact Hours, and Prep Hours** for each course in the fields provided.

Click on **Save** to update the course hours.

Use the **Add new Course** table to **ADD** courses you taught that are not listed. You should add elective courses since they are not included in the E-curriculum database. To add a course:

- Start typing the Course Number or the Course Title in the appropriate text box in the Add a Course table. The available courses will display

for you to select from and will pre-populate both the Number and Title fields.

- Enter the number of Formal Teaching Contact Hours, Other Contact Hours, and your Prep Hours for the course
- Check the contact type categories given under the Contact Hours column
- When the information for the course is complete, click the ADD button at the end of the row.
- The course will be added to the list of your other courses in the table above.

REMOVE courses you did not teach. To remove a course, click the REMOVE button at the end of the row for that course.

3. SOM undergraduate and graduate student courses

This category includes SOM classroom and laboratory instruction taught by you in formal, numbered courses which are listed in the VCU Course Bulletin. SOM course numbers start with one of the following 4-letter codes: ANAT, BIOC, BIOS, EMSA, EPID, HGEN, IBMS, IDAS, MEDP, MICR, NEUS, PATH, PHIS, PHTX, SBHD.

Enter the **Formal Teaching Contact Hours, Other Contact Hours, and Prep Hours** for each course in the fields provided.

Use the **Add new Course** table to **ADD** courses you taught that are not listed. To add a course:

- Start typing the Course Number or the Course Title in the appropriate text box in the Add a Course table. The available courses will display for you to select from and will pre-populate both the Number and Title fields.
- Enter the number of Formal Teaching Contact Hours, Other Contact Hours, and your Prep Hours for the course

Enter the GEM conference details in this section. Enter the **average number of hours spent per week** on GEM conference activities.

6. VCU (non-SOM) professional, undergraduate and graduate courses

This category includes Classroom and Laboratory instruction taught by you in Formal, Numbered **non-SOM** Courses which are listed in a VCU Course Bulletin.

Enter the **Formal Teaching Contact Hours, Other Contact Hours, and Prep Hours** for each course in the fields provided.

Use the **Add new Course** table to **ADD** courses you taught that are not listed. To add a course:

- Start typing the Course Number or the Course Title in the appropriate text box in the Add a Course table. The available courses will display for you to select from and will pre-populate both the Number and Title fields.
- Enter the number of Formal Teaching Hours, Other Contact Hours, and your Prep Hours for the course
- Check the contact type categories given under the Contact Hours column
- When the information for the course is complete, click the ADD button at the end of the row.
- The course will be added to the list of your other courses in the table above.

REMOVE courses you did not teach. To remove a course, click the REMOVE button at the end of the row for that course.

Use the **Add new trainee type** feature to add clinical teaching contact hours. Select the Type of Trainee and provide the Formal Teaching Contact Hours and Other Contact Hours. Click the ADD button to add the entry to the list.

To remove an entry, click the REMOVE button at the end of the row.

If you make an error, REMOVE the entry and ADD it again, or modify the entry in the grid and click SAVE.

b. Clinical Teaching Activities Description

Describe your clinical teaching activities during this reporting period.

9. Time spent on teaching in clinical setting

Enter the **average number of hours spent per week** on teaching in clinical setting reported above in item#7.

10. Intramural seminars and/or lectures

Use the **Add seminars/lectures** feature to add intramural seminars and/or lectures you presented during this reporting period. Select the Type of Seminar/Lecture and the Principal Sponsoring Department from the drop-down lists, briefly describe the Topic and provide the Total Number of Contact Hours for each. Click the ADD button to add the entry to the list.

To remove a resource, click the REMOVE button at the end of the row.

If you make an error, REMOVE the entry and ADD it again, or modify the entry and click SAVE.

11. Teaching portfolio – Instructional techniques and course management aids used

Check the appropriate boxes for the instructional techniques and course management aids you have incorporated in your courses during this

reporting period.

b. Other techniques and aids used

If you selected “Other” in 6a, describe the other instructional techniques and course management aids in the space provided.

12. Educational innovations

Describe educational innovations you have made or contributed to during this reporting period.

13. Teaching resources developed

Use the **Add new resource** feature to add teaching resources you developed during this reporting period. Select the type of resource and the primary audience from the drop-down lists and briefly describe the resource in the space provided. Click the ADD button to add the entry to the list.

To remove a resource, click the REMOVE button at the end of the row.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

14. Time spent on teaching activities

Enter the average number of hours spent per week on teaching activities reported above in items 9 through 12: preparing and delivering intramural lectures and seminars, learning and implementing instructional techniques, developing teaching resources, and educational innovations.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

e. High school/undergraduate research

Use the **Add new student** feature to provide the name, education level for each high school and undergraduate research student you have advised/mentored during this reporting period, name of summer research program through which you hired the student, and a brief description of your role. Click the ADD button to add the entry to the list.

To remove a student, click the REMOVE button at the end of the row for that course.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

f. Other academic advising/mentoring activities

List the names and educational levels of students you have advised/mentored in other schools and/or programs.

16. Time spent on academic advising and teaching

Enter the average number of hours spent per week on academic advising and mentoring activities.

17. Extramural teaching

The list of extramural teaching activities (i.e. teaching outside of VCU) is downloaded from your Outside Professional Activities (OPA) records. To include additional activities, log in to [OPA System](#) and complete the CP-1 form for each extramural teaching activity. In order for an activity to be considered extramural teaching, the activity type must be set to one of the following values: "Giving occasional lectures / seminars at other institutions" or "Teaching a course at another institution".

18. Time spent on extramural teaching

Enter the average number of hours spent per week on extramural teaching activities.

19. Teaching Administration

List all teaching administration roles you have held during this reporting period. For each teaching administration role, provide a brief description of your assignments along with the date of appointment and **hours spent weekly** on each appointment. Do NOT list committee roles here. All committee participation should be reported in the "Service" section.

Use the **Add Teaching Administration Role** feature to add entries to your list. Once you have entered the information, click the ADD button at the end of the row to add the entry to your listing.

Click the REMOVE button at the end of the row to delete an administrative leadership role.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

22. Actual Effort %

The Actual Effort % grid (shown below) displays the Approved Projected Effort %, Actual Time Spent, Actual Effort %, and Projected Effort for Teaching, Research, Clinical, Service, Administration, and Professional Development activities.

This grid appears on all sections of the Activity Report so the data can reviewed/updated without having to switch screens.

The Approved Projected Effort (%) is populated from the Performance Plan form entered and approved in FARES last year. If you did not complete the Performance Plan form last year, this column will be blank.

The Actual Time Spent is calculated by adding hours/week reported in various sections of the Activity Report.

The Actual Effort % is computed by dividing Actual Time Spent by the Sum of Hours Worked reported on different pages in your activity report.

Enter your Projected Effort Percentage for next year.

Your total percentage of effort (actual and projected) cannot exceed 100 percent*, since that percentage represents your total effort.

*As you are working on your Activity Report and Self-evaluation, the total effort % can be less than or more than 100%, but FARES will only allow you to SUBMIT your completed report if the total of your Actual Effort and Projected Effort is equal to 100%.

- b. If you referred patients for clinical trials, click on Yes.
- c. Describe your role in clinical trials and patient referrals in the box provided.

8. Time Spent on Other Research Activities

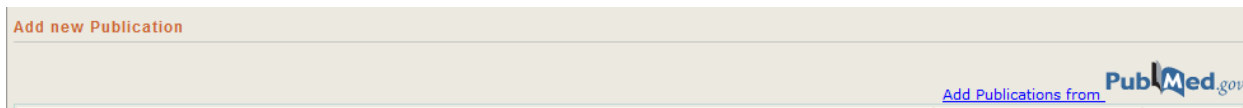
Enter number of hours spent per week on other research activities such as preparation of grant proposals, preparing and submitting applications for bridge funding, attending meetings to discuss on-going internally funded research projects, discussions with collaborators, developing new research programs, research administration (outside of funded research), and submission of applications for patents, inventions, and copyrights.

9. Professional Publications

List all professional publications and their status (published, submitted, in press) for the current reporting period. Use Citation Format of [Citing Medicine: The NLM Style Guide for Authors, Editors, and Publishers](#). **For peer-reviewed articles published in PubMed Central, include the PMID at the end of the full citation.**

There are two ways you can add a publication in FARES.

- a. FARES now pull a list of publications from PubMed database with the author name that matches with faculty name. You can see this list by clicking the “PubMed.gov” logo located under Add New Publication section on the Research page. Below is the image how it looks in FARES,



Clicking this logo will open up a window with all publications that matches with faculty’s name. System provides a “Select” button for each publication to add to faculty’s list of publications in FARES. Below is the image how the pop-up window looks in FARES,

For each publication, indicate if you worked with a student, postdoctoral associate, and/or resident/fellow.

Click the REMOVE button at the end of the row to delete a publication.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

10. Presentations

List all research presentations which you personally delivered. Use Citation Format of [Citing Medicine: The NLM Style Guide for Authors, Editors, and Publishers](#).

Use the **Add new presentation** feature to add presentations to your list. Once you have entered the information, click the ADD button at the end of the row to add the entry to your listing.

Click the REMOVE button at the end of the row to delete a presentation.

If you make an error, REMOVE the entry and ADD it again, or modify the existing entry and click SAVE.

11. Time Spent on Scholarly Activities

Enter number of hours spent per week on scholarly activities - writing and/or editing professional publications and presentations.

12. Faculty member self-evaluation narrative

Evaluate your performance for research and scholarship activities in the space provided. What were your performance highlights or important achievements in the past year? What could have been most improved regarding performance in the past year?
