

Eligibility

Faculty, administrators, residents, students, postdocs, or a candidate may nominate any SOM faculty member teaching in undergraduate medicine, graduate education, graduate medical education, continuing education, or other schools/programs. **Previous nominees’ packets may be updated and resubmitted with a current CV (separate) and nomination package of no more than 20 pages total, single-sided, including nomination form.**

What to include in the Nomination Package

1. This Nomination Form.
2. All nomination packages including resubmitted packages should be no more than 20 pages total, single-sided. The 20-page total includes the nomination form.
3. An up-to-date curriculum vitae, separate from the 20-page limit on nomination materials.
4. Nomination materials may include, but not limited to, letters of support (addressed to Peter Buckley, MD, Dean, SOM) stating why your nominee should be chosen for the award, as well as student evaluations, educational activities, examples, innovations, outcomes (please be judicious, succinct, and creative).
